1. Background and Objectives

Background

Agricultural development is a key to reach the Millennium Development Goals (MDGs) since three quarters of poverty population of developing countries lives in rural area and agricultural development is more than twice as effective for poverty reduction as developing other sectors, according to the World Bank report.

Recognizing the need for agricultural development in developing countries, the government of Republic of Korea has been increasing a portion of the budget for assistance in agriculture and rural sectors. For this year, the budget of Ministry of Agriculture, Food and Rural Affairs (MAFRA) for ODA is 12.8 billion won, which has been increased from 0.4 billion won in 2006.

In addition, MAFRA and Korea Rural Economic Institute (KREI) initiated a new program called "Korea Agricultural Policy Experiences for Food Security (KAPEX)" this year, which is to develop a framework for improving national food security of developing countries through joint survey/research project, and local and invitational trainings. As part of the program, KREI conducts policy workshops for sharing ideas and experiences, and presenting outcomes of KAPEX program.

Also, Hankyong National University (HKNU) has been conducted ODA cooperation projects in many countries including Uganda and Myanmar and holds seminars to share the cases of international cooperation in agricultural sector. Particularly, HKNU shares the cases of cooperation projects focusing on successful cases of dispatching volunteer corps to developing countries and transfers the experiences of managing courses in university.

Therefore, it is concurred to conduct a seminar on international cooperation in the field of agricultural development under the joint auspices of KREI and HKNU.

Objectives

- To present the outcomes of KAPEX programs and share ideas for future ODA projects for partner countries of KAPEX
- To share the cases of international cooperation in agricultural sector and introduce training programs of HKNU for raising experts in the field of international cooperation
- To strengthen the network among institutions in the related field and develop foundation for sharing information and enhancing future collaborations among related institutions and companies by establishing Public-private partnership network
